

Warranty Statement

SsangYong Motor Co. Korea, hereinafter called the manufacturer, warrants to the owner that each SsangYong vehicle shall be free, under normal use and maintenance, from any defects in material and workmanship as a result of vehicle manufacturing, subject to the following terms and conditions.

1 Warranty Period

The warranty period for all coverages begins on the date the vehicle is first registered and ends at the expiration of the complete vehicle coverage or other special coverage's shown below.

A. Complete Vehicle Coverage

The complete vehicle (except those items listed under "what is not covered") is covered for specific time and mileage, whichever comes first for your vehicle. Please see specific details in vehicle listings,

B. Corrosion (Rust-Through) Coverage

Any sheet metal panel that rusts through due to corrosion is covered for 6 years regardless of mileage, rust resulting from stone chip or any other external damage/impact is not covered.

C. Paint Coverage

The initial paint finish is covered for three years, regardless of mileage.

2. What is Covered

Except as provided in paragraph 3 hereof, an authorised SsangYong dealer shall either repair or replace, as necessary, any SsangYong genuine part that is defective in material or workmanship within the warranty period set out in paragraph one, without charge to the owner of the SsangYong vehicle.

3. Items not Covered in the Warranty

A. Repair or replacement required not as a result of defects in material or Workmanship by the manufacturer but as a result of i) accident, ii) misuse, iii) lack of proper maintenance, iv) repairs improperly performed or replacements improperly installed by any person other than an authorised SsangYong dealer ,v) usage of any fuel other than that specified for the SsangYong vehicle, vi) alterations by changing or adding to the vehicle, vii) damage from environmental conditions such as airborne fallout , salt , hail , windstorm , lightening , flood and the like .

B. Any SsangYong vehicle equipment subject to normal driving wear and tear,

Including without limitation, filters, spark plugs, drive belts, fuses, clutch facings, brake linings, wiper blades, and the like.

- C. Normal maintenance service including, without limitation, cleaning and / or vehicle polishing, lubrication, adding coolant, an engine tune-up.
- D. Any SsangYong vehicle on which the odometer mileage has been altered or on which the actual mileage of the SsangYong vehicle cannot be readily determined.
- E. Extra expenses including, without limitation, payment for loss of use of the vehicle, lodging bills, vehicle rentals, other travels costs and loss of pay.

Tyre warranty

Tyres installed as original equipment on SsangYong vehicles are warranted by their respective manufacturers and are not warranted by SsangYong Motor Co. Korea.
